### **“The Evidence Shows: Better Laws Mean Better, More Accessible Care”: Webinar References**

On February 23, 2016, the Center to Champion Nursing in America hosted “The Evidence Shows: Better Laws Mean Better, More Accessible Care.” In the webinar, Joanne Spetz, PhD, FAAN, director of the University of California, San Francisco Health Workforce Research Center, reviewed research on the effect scope of practice laws for nurses had on the health of the American public.
